Howdee residents of The Village of Port Edwards. I am going on one year as your administrator and my family and I are enjoying every day here in Port Edwards. We all continue working to make each day a great day here in Port.

We have all weathered thru another Winter and Spring is flying by. The weather change is very inviting. The Vaccine is flowing out and by the time of this newsletter over 50% of our Village will have received the vaccine. We hope by the

end of the Summer we will be 100% vaccinated. Let's continue to do what's right, get the vaccine and take all appropriate precautions that you feel are correct.

We will be taking on some major infrastructure projects this year. We plan to complete a total rebuild of our 3<sup>rd</sup> Street from Edwards Ave to Letendre Ave. We also plan to resurface our 1<sup>st</sup> Street from Letendre to Ver Bunker Ave. There will be some minor alley repairs, and this will be the first year we improve our Bike trails working on the northern section from Ver Bunker to Seneca Road. We will as usual repair about 1000' feet of curb and gutter as well as sidewalks throughout the spring and summer. We continue to improve our parks and we hopefully will have a ribbon cutting on our New Dog park and Veteran's memorial later this summer, more to follow. We continue to make progress with DMI and the Old Mill property and hope to unveil some development plans for the site. We will also start our dialogue with the NEPCO lake residents planning for the Boundary agreement to end in a few years. Those 200+ residents will return back to the Village and we hope to make that a seamless and positive transition. Your Village leaders had a great strategic planning session last month to help chart the course for our Village over the next 10 years, we will publish that report in the near future and continue to ask for opinions moving forward.

It continues to be my goal to make this a very *Professional, Ready and Relevant* Village staff. We have numerous challenges ongoing and ahead that we all need to work together to overcome. Our Village services need the right investment to support all our residents and businesses in Port Edwards. I will be asking for ideas and help to identify some community events to conduct this summer, cookouts, food truck events, outdoor movies, etc. we need to regain our small village atmosphere and start gathering as a community, I look forward to the discussion and ask for your help to execute these initiatives.

# SUMMER NEWS FROM THE FIRE DEPARTMENT

Outside cooking fires / campfires in the Village have restrictions that need to be followed. These regulations are intended to make recreational burning a safe and enjoyable experience without making someone else uncomfortable. The following is an excerpt from the Village ordinance:

#### 5.14 OPEN BURNING REGULATED.

(1) PROHIBITED BURNING. It shall be unlawful to burn leaves and trash of any kind.

(2) RECREATIONAL BURNING. Open recreational burning is permitted in a fire pit; a minimum 3-sided enclosure; or a gas, electric or charcoal kettle, subject to the following:

(a) The fire is monitored by a responsible person until the fire is extinguished or burns out.

(b) The fire is not lit on windy days or when atmospheric conditions will endanger the public health or safety.

(c) The fire is located off the public right of way and in excess of 30 feet from the residence of another.

(d) The fire is not used for the covert burning of plastic, rubber, garbage or other offensive materials.

(3) BURNING BY PERMIT. Burning permits for burning brush in nonresidential areas may be issued by the Fire Chief (or designate. Contact the Village clerk during regular business hours to arrange for a permit. The part in parenthesis was added by the Fire Chief.) Burning permits for residential areas may (only) be approved by the Village Board.

(4) LIABILITY. Any person open burning, whether permitted or not, which results in a response by the Village Fire Department shall be billed for the cost of such response.

The Port Edwards Firefighters Street Dance is June 18<sup>th</sup>. Food, raffle tickets and refreshment sales will start at 5:30 pm. Bring the family and friends for supper and stay for the music. The band Road Trip will play from 7:30 pm to 11:30 pm. There is no admission charge.

#### Sprinkling Restrictions

Lawn sprinkling restrictions begin on June 15<sup>th</sup>. Odd-numbered addresses will sprinkle on oddnumbered days and even-numbered addresses on even-numbered days.



Likewise, sprinkling is only allowed from 6:00 P.M. until 10:00 A.M. Please help conserve water by sprinkling during the early morning or evening hours.

Sprinkling restrictions end on September 15<sup>th</sup>.

#### <u>Cemetery Maintenance &</u> <u>Allowable Decorations</u>

The Village of Port Edwards takes great pride in the appearance and upkeep of the cemetery. The rules of the cemetery limit what can be placed for decorations. Only traditional flower plantings are allowed at the cemetery. Please be aware that if you have items that are not flowers (such as lights or other objects) they may be removed and disposed of. The Village asks that all people enjoying the cemetery abide by the rules established to keep the Port Edwards cemetery one of the nicest maintained in the region.

#### Leaf, Grass and Brush Pickup

On a weekly basis, the crew will pick up grass that is properly placed. Typically grass pickup is on Mondays and Tuesdays. Brush will be picked up on the same week as recycling.

All brush and grass must be placed <u>on the</u> <u>boulevard area behind the curb</u> making sure that there are no rocks or foreign objects in the piles. PLEASE NO BAGGING OF YARD WASTE!!

- Grass and leaves must be placed separate from brush.
- Brush must be stacked neatly with the cut end facing the street.



 Roots must be removed and placed separately from the branches

If you need compost or wood chips, please contact the Municipal Building to arrange delivery of the material. Delivery is free to Village residents.

#### Garbage and Recycling

Please remember to place your weekly garbage and bi-weekly recyclables out for curbside

pickup by **6:00 AM** each day of pickup. Recycle pickup is every other week on your regular garbage day. LOOSE GARBAGE MUST



<u>BE PUT IN BAGS BEFORE PLACING IN</u> <u>CONTAINER!!</u> Please note that pizza boxes are <u>not recyclable</u>. If you experience less than satisfactory service, please give us a call at the Municipal Building, 715-887-3512.

After collection, containers shall be removed from the curb or roadside (including alleys) within 12 hours.
