#### Spring Election – April 4, 2023

There are seven candidates for Village Trustee; therefore, this race will be included on the ballot at the <u>Primary</u> <u>Election to be held on Tuesday, February 21, 2023</u>, in order to bring the number down to six candidates to be placed on the Spring Election ballot.

## Meet the Village President Candidates:

# FROM THE DESK OF THE VILLAGE ADMINISTRATOR



Residents of The Village of Port Edwards. Greetings from your Village Administrator, Raymond "Boz" Bossert. All goes well in our Village and I am excited about the challenges ahead. We continue to make progress across all areas in our Village and provide the best services one can expect.

We are weathering thru another Winter season and it has been very interesting. Sporadic snow, very cold weather, but all is well.

Now onto Village Business.... We have approved and are executing our 2023 Budget. All looks good. We will bring in about \$5 Million dollars in 2023 in revenue and this year's

budget we planned to expend about \$3.9 million. The difference is kept in our Reserves and long-term planning accounts. Our expenses were less in 2023 than past years and we are coping like everyone with the + 8% inflation. We will continue to find innovative ways to get the most out of every dollar we have as a Village, Fiscal conservatism is our watchword. Due to our Total assessed value being in the low 60% range, after 17 Years the Village will need to conduct a full re-valuation of all parcels. The State rule is that assessments need to be closer to 95% for the tax base and we need to reach that goal so we can start the lowering of the millage rate for all residents next tax year. You will be receiving some correspondence from the Village and the Assessor explain the process.

We will be taking on some major infrastructure projects this year. We plan to begin the planning for the 2<sup>nd</sup> street full repair from Ver Bunker to Monroe Ave. We also plan to resurface 3-4 alleys across the Village and some major resurfacing of 2<sup>nd</sup> street Infront of the High school. Depending on the federal funds that come our way we may increase some other projects in the Village, but more to follow. We will as usual repair about 1000' feet of curb and gutter as well as sidewalks throughout the spring and summer. We continue to improve our parks and we hopefully will have our official ribbon cutting on our New Dog park in early Spring, more to follow. We continue to make progress with DMI and the Old Mill property and hope to unveil some development plans for the site. We continue our dialogue with the NEPCO lake residents planning for the Boundary agreement to end in a few years. Those 200+ residents will return back to the Village in 11 months and we hope to make that a seamless and positive transition.

It continues to be my goal to make this a very *Professional, Ready and Relevant* Village staff. We have numerous challenges ongoing and ahead that we all need to work together to overcome. Our Village services need the right investment to support all our residents and businesses in Port Edwards. We must be good stewards of our tax funds and choose wisely on investments and budgets. The best use of tax funds and service fees are only amplified when we have resident "buy in" on our initiatives and projects. I look forward to working on these issues together moving forward.

I am excited and look forward to the challenges. Let's get to work and stay "PORT PROUD!"

### Wastewater Rate Increase

A 2.5% rate increase was implemented effective January 1, 2023. Please note that you will see this increase on the April 1, 2023 billing.

Billing: Bills for water service are rendered quarterly and become due upon issuance following the period for which service is rendered. A late payment charge of 3 percent but not less than 50 cents will be added to bills not paid within 20 days of issuance. This one-time 3 percent late payment charge will be applied to any unpaid balance for the current billing period's usage. This late payment charge is applicable to all customers. The utility customer may be given a written notice that the bill is overdue no sooner than 20 days after the bill is issued, and unless payment or satisfactory arrangement for payment is made within the next ten days, service may be disconnected pursuant to Chapter PSC 185, WI Admin. Code.

# **MONARCH GARDEN**



In looking at the snow outside my window, it's hard to believe that spring will soon be springing! We will be anxiously awaiting the first signs of our "monarch" plants showing signs of new growth and the milkweed popping up through the soil. As you may know, the monarch numbers were greatly decreased last year. Our diligent "monarch egg hunters" had a terrible time trying to find eggs and there weren't enough to even put in the viewing hut. Quite a change from the previous year! According to a June article in Science Daily, populations

are decreasing in some places and increasing in others. This could be due to the extensive use of "Round Up" and like chemicals on fields and yards. Also, cooler spring temperatures cause a lower population in monarchs as they choose a warmer climate and keep moving on until they find one. Findings show that there has been an increase in parasites invading the monarch before migration to Mexico therefore causing them demise before reaching their destination. Along with parasite infection, illegal logging of migration forests is occurring and forest land has been drastically reduced preventing the monarchs from their usual place to colonize.

We sincerely hope that we can do all we can to provide a monarch healthy and friendly environment. Please consider planting milkweed and plants that produce pollen for our nectar-loving friends. If you have weeds, please consider natural ways to remove them other than spraying harmful chemicals. If you have questions, please contact Pat and Kathy McGrath through FB-Friends of the Monarch. The garden doesn't happen on its own, so a special thank you to the McGraths, Leverances, and Judy Miller for all your hard work and expertise. I will be retiring from the bank on April 29th but will still tend to the monarch garden. If you would like to join me, grab a trowel and come down and do some planting and weeding. Thanks to all fellow monarch lovers!

## Greetings from the Port Edwards Police Department!

Even though there is still snow on the ground, it will not be long until our village is buzzing with outdoor activities. While navigating our streets and alleyways, please slow down and watch for pedestrians.

For those new to our community, the Port Edwards Police Department offers alert stickers for people who are mentally or physically disabled, deaf or hard of hearing, have dementia or Alzheimer's, or have autism spectrum disorder. These stickers are provided free of charge while supplies last. You may pick up your stickers at the Port Edwards Police Department, Port Edwards Municipal Building or by emailing scott.drew@portedwardswi.gov We recommend placing an alert sticker at all entry doors, so it is visible for all Emergency Responders.



The Police Department also has "Project Child Safe" gun locks available to anyone who is interested. These gun locks are free of charge and are available at the police department or by emailing the email above.

With tax time upon us, please watch for tax related scams. Use only reputable tax preparers and keep your private information private. Never share your information over the phone, especially if you receive an unsolicited call. If you believe you have been victimized by a scam, you can visit IdentityTheft.gov for guidance, or contact the police department and we can assist you with the situation.

## NOTES FROM THE FIRE CHIEF'S DESK

**100 YEARS!!** That is a long time... The Port Edwards Fire Department was established in 1923, with many people who have served, (and continue to proudly serve) the Village of Port Edwards. Saturday May 20<sup>th</sup> from 9:00 - 3:00 Village wide garage sale, we will be hosting an Open House and Brat Fry fund raiser- Stop down to enjoy some food, drinks, and see our equipment.

Friday June 16<sup>th</sup> from 4:00 – Midnight, 100<sup>th</sup> Anniversary Port Edwards Street Dance featuring the bands, Genesee Depot and Road Trip- Our annual street dance will be bigger and more fun! This will be held at the station again, and is our biggest fund raiser. Two bands this year, homemade

food, food trucks, drinks, prizes, raffles! Please stop down and support your local Fire Department. We hope to see you all there!

Remember to control your campfires and make sure they are out cold before leaving them unattended. If you burn brush, make sure to get a permit. In the village you can only burn in nonresidential areas between the hours of 6pm and midnight. No burning is allowed on Sundays or holidays. Below is the portion of the village ordinance pertaining to open burning;

#### 5.14 OPEN BURNING REGULATED.

(1) PROHIBITED BURNING. It shall be unlawful to burn leaves and trash of any kind.

(2) RECREATIONAL BURNING. Open recreational burning is permitted in a fire pit; a minimum 3-sided enclosure; or a gas, electric or charcoal kettle, subject to the following:

(a) The fire is monitored by a responsible person until the fire is extinguished or burns out.

(b) The fire is not lit on windy days or when atmospheric conditions will endanger the public health or safety.

(c) The fire is located off the public right of way and in excess of 30 feet from the residence of another.

(d) The fire is not used for the covert burning of plastic, rubber, garbage or other offensive materials.

(3) BURNING BY PERMIT. Burning permits for burning brush in nonresidential areas may be issued by the Fire Chief, a local Emergency Fire Warden, over the phone by calling 1-888-WIS-BURN, or online at <u>http://dnr.wi.gov</u> using the keyword "Fire". Burning permits for residential areas may be approved by the Village Board.

(4) LIABILITY. Any person open burning, whether permitted or not, which results in a response by the Village Fire Department shall be billed for the cost of such response.

As always, we are looking for new members who would like to serve the community as a firefighter or first responder. We're a great group of people with friendly attitudes, who enjoy helping others. We work hard and play harder. If you are interested, please stop down and let's talk.

#### Spring Cleanup

The Village takes pride in being a very clean community. Residents expect the Village government to enforce the rules when it comes to garbage, clutter, and vehicles. Please remember:

- Garbage, appliances, clutter, etc. is not permitted to be left in public view.
- Campers, boats, etc. must be parked and stored BEHIND or ALONG SIDE of houses. They are not allowed to be parked in front of the house or on the street other than for actual loading or unloading.
- DOG FECES IS NOT YARD WASTE. Raking dog feces into grass piles for the village crew to pick up will not be tolerated. Residents doing so will be referred to the Police Department.

#### Leaf, Grass and Brush Pickup

As the winter ends and we start to get outside again, please remember the following:

On a weekly basis, the crew will pick up grass that is **properly** placed. Typically grass pickup is on Mondays and Tuesdays.

# PLEASE NOTE: Brush will be picked up on the same week as recycling.

Please be conscientious when placing waste at the curb. Be sure no foreign objects, such as stones, metal, etc. are mixed in with the waste. One piece of metal can completely ruin a \$300 set of chipper blades. Repairing equipment takes time and money and results in delays in picking up waste so PLEASE BE CAREFUL.

- All brush and grass must be placed on the boulevard area behind the curb.
- Grass and leaves must be placed separate from brush.
- Brush must be stacked neatly with the cut end facing the street.
- Roots must be removed and placed separately from the branches.

The Village generates many tons of compostable material each year. If you need compost or wood chips, please contact the Municipal Building to arrange delivery of the material. Delivery is free to Village residents.

#### **Shelter Reservations**

Reservations for the Ripple Creek Park outside shelter and Edwards-Alexander Memorial Park enclosed and outside shelters can be made by calling the Municipal Building at 715-887-3512.

Current prices for using the Enclosed Shelter are:

- Resident fee without kitchen \$100.00
- Resident fee with kitchen \$125.00
- Non-resident fee without kitchen \$125.00
- Non-resident fee with kitchen \$150.00

A \$25.00 refund will be issued if the building is left clean.

Residents can reserve the outside shelters free of charge while non-residents are charged \$35.00.

#### **Garbage and Recycling**

Please remember to place your weekly garbage and bi-weekly recyclables out for curbside pickup by **6:00 AM** each day of pickup. <u>Also</u> remember that the day for pickup is Wednesday. <u>Garbage & Recyclables</u>



must fit in the bin with the lid closed. Please note that pizza boxes are not recyclable. If you experience less than satisfactory service or if you have any questions,

please do not hesitate to give us a call at the Municipal Building, 715-887-3512.
