# <u>Leaf Pick-up</u>

It is again that time of year for leaves. Due to the tremendous quantity of leaves put out in just a short time, please remember to place leaves in the gutter section of the street in a long row along your property. <u>Only leaves may be placed along the gutter</u> and please note that <u>this is the only time of</u> <u>the year that anything can be placed in the</u> <u>gutter</u>.

Separated piles of brush and grass must be placed on the boulevard area behind the curb and the brush must be stacked neatly with the cut ends facing the street. Also, roots must be removed from the brush and placed separately from the branches.

If you follow these rules, your leaves and other yard waste will be picked up in a timely manner.

# Flag Donations

The flag project is funded entirely from private donations and the flags require replacement every one to two years, so donations are always welcomed and encouraged so we can keep our flags flying bright and proud. The cost of one flag is approximately \$30.00.

## FALL / WINTER NEWS FROM THE FIRE CHIEF'S DESK!

The nights are getting cooler, the days are getting shorter, and fall and winter will soon be upon us. Fire prevention week is October  $4^{th} - 10^{th}$ . Please mark your calendars, this is a great time to change your batteries in your smoke detectors and make sure they are operating properly. The Law is one smoke detector minimum per floor and this also goes for carbon monoxide detectors. These two things that have been proven to save lives. This is also a great time to go over your escape plan with your children if you have them; if not still go over your planned two routes out of your home.

If you burn wood in your home please have your chimney cleaned and inspected yearly. Also, avoid the seasonal rush and have your furnace inspected/ serviced before you need to use it. We really don't want to come to your home and make a big mess because of a lack of preventative maintenance.

With heavy and drifting snow, please remember to keep all your furnace exhaust vents on your home clear of ice and snow blockage. This is a common reason fire departments are called to homes for carbon monoxide detectors going off or people getting headaches or feeling sick. It only takes a minute to check.

At this time I would like to ask everyone a big favor, please help us out during the winter and the snow season. If you have a fire hydrant by your home or even close, could you please keep it cleaned out for us? This is really important if we need to use it, because every minute a fire burns it doubles in size. It is recommended a 3 foot by 3 foot area around the hydrant be cleared. This gives us the area we need to do our job if needed.

# Hello from the Port Edwards Police Department!

#### Traffic Safety / School Zone Crossings:

School is back in session, so our children will be out walking and biking to and from school. Please use extra care and SLOW DOWN in the school zones at 5<sup>th</sup> Street/Letendre Avenue and 5<sup>th</sup> Street/Ver Bunker Avenue. Our Crossing Guards, Debbie and Randall will be out making sure our kids cross safely. Please do your part when you see children in the area and maintain

the 15 MPH speed limit through the school zone. Our crossing guards are appointed by the Police Department and will report all violations directly to the Police Department for enforcement. Fines start at \$111.40.

#### Vehicles to stop at stop signs and school crossings.

<u>346.46(2m)</u> Every operator of a motor vehicle approaching a school crossing which is controlled by an adult school crossing guard



appointed under s. <u>120.13 (31)</u> or <u>349.215</u> shall follow the directions of the school crossing guard. If directed by the school crossing guard to stop, the operator shall stop the vehicle not less than 10 feet nor more than 30 feet from the school crossing and shall remain stopped until the school crossing guard directs the operator to proceed.

#### Yielding to Emergency Vehicles:

I have noticed a lot of confusion lately about what to do when an emergency vehicle is approaching. I have had vehicles pulling into center medians, stopping in the left lane of traffic, continuing to the next cross street, and otherwise not yielding to the emergency vehicles. What should you do when you see an emergency vehicle approaching from the front or rear? The short answer is, PULL TO THE RIGHT AND STOP.

Wisconsin law (State Statute 346.19) states that operators of a vehicle shall yield the right-ofway and shall immediately drive their vehicle to a position as near as possible and parallel to the right curb or right-hand edge of the shoulder of the roadway, clear of any intersections. <u>This applies to emergency vehicles that are using an air horn, siren or flashing</u> lights, including police vehicles, fire trucks, and ambulances. The owner of a vehicle involved in a violation of s. 346.19 (1) for failing to yield the right-of-way to an authorized emergency vehicle shall be liable for the violation.

# **Port Edwards Water Utility Rates**

The Public Service Commission requires that water rates be published semi-annually. The following rates took effect on September 18, 2023 and will be on your January 1, 2024 water bill:

#### **Plus Volume Charge:**

First 25,000 cubic feet used each quarter - \$1.41 per 100 cubic feet Next 375,000 cubic feet used each quarter - \$1.26 per 100 cubic feet Over 400,000 cubic feet used each quarter - \$0.94 per 100 cubic feet Quarterly Service Charge for Sprinkling Meter: 5/8" meter - \$ 5.40 1" meter - \$ 10.50

1 ½" meter - \$ 21.00 2" meter - \$ 28.00



Billing: Bills for water service are rendered quarterly and become due upon issuance following the period for which service is rendered. A late payment charge of 3 percent but not less than 50 cents will be added to bills not paid within 20 days of issuance. This one-time 3 percent late payment charge will be applied to any unpaid balance for the current billing period's usage. This late payment charge is applicable to all customers. The utility customer may be given a written notice that the bill is overdue no sooner than 20 days after the bill is issued, and unless payment or satisfactory arrangement for payment is made within the next ten days, service may be disconnected pursuant to Chapter PSC 185, WI Admin. Code.

#### Water & Sewer Billings

Water and sewer billings are quarterly, the 1<sup>st</sup> of January, April, July, and October with the bills due 20 days later. After late notices are sent out you have ten days to pay or your water will be shut off. If your water has been shut off, there is a \$20.00 reconnect charge. Water bills can be paid at the Municipal Building from 8:00 a.m. - Noon and 1:00 p.m. - 4:00 p.m., dropped in the silver payment box in front of the Municipal Building, or mailed in.

## **Garbage and Recycling**



Please remember to place your weekly garbage and bi-weekly recyclables out for curbside pickup by **6:00 AM** each day of pickup. Recycle pickup is every other week on your regular garbage day. <u>LOOSE GARBAGE MUST BE PUT IN BAGS BEFORE PLACING IN</u> <u>CONTAINER!!</u> Please note that pizza boxes are not recyclable. If you experience less than satisfactory service, please give us a call at the Municipal Building, 715-887-3512. **After collection, containers shall be removed from the curb or roadside (including alleys) within 12 hours.**
