The village board continues to work on making our village a beautiful and safe place to live. We continue to strive to give our village the best possible services, while being cognizant of how we are utilizing tax dollars. Our village crew have been taking care of our streets to make sure they are safe to drive on when we do get ice or snow. They also have been able to get some more "spring like" projects done because of the unusually warm weather. We have entered into a contract with the City of Wisconsin Rapids for ambulance service to provide a quick response and exceptional care to village residents. We also have contracts with surrounding communities for our fire department to respond to them in their times of need. We are working towards adding a Community Resource Officer, subject to a grant. The village and the Port Edwards School district have collaborated in this effort. The officer would work and support our schools during the school year and of course with the rest of the community throughout the year.

If you have not noticed yet, El Cafe added on to their restaurant! They have purchased the space right next to their existing property and opened a bigger room where you can have larger groups or even hold meetings! The other, bigger parcel, next to El Cafe was also purchased and is in the renovating phase! We are continuing to work on the sale of the parcel to Mission Coffee and hope to have that finished up soon. Let's make sure to continue to support all our local businesses! Welcome to spring, Village of Port Edwards residents. I want to take a few moments of your time to inform you of events and projects planned for this year.

The weather change is very inviting, and I hope everyone takes advantage of the outdoor activities we have regionally. We plan to conduct some local events in the Village with Rummage Sales, Music Fests at Ripple Creek, Firefighter's Street Dance, Lions Picnic, Trunk-

or-Treat and Christmas Tree Lighting, and look forward to seeing many of you there.

We will be conducting one major infrastructure project this summer- 2nd Street from Ver Bunker to Monroe, with new sewer line, water line, storm sewer line, sidewalks, curb and gutter, and pavement. The project is to start in June and be completed by September. We will also be replacing over 1000 feet of sidewalk repairs, chip sealing of subdivision streets and resurfacing of two alleys.

We continue to improve our parks with new facilities. Our dog park is fully functional, and working with a citizen group, we plan to improve our disc frisbee park at Ripple Creek. The Village was awarded a Legacy grant that is being used for a bike trail on Port Road from Ver Bunker Avenue to a safe crossing at Hwy 54/73 to connect to the existing bike trail on Hwy 54/73. Construction is set to begin in 2024 and be completed during the summer of 2025.

This spring and summer the Wisconsin Department of Transportation will be working on resurfacing Hwy 54/73 through the Village from Port Road to Seneca Road. Work will consist of removing the top 3.5 inches of pavement and replacing with 3.5 inches of new asphalt pavement. The project will also upgrade crosswalks, curb ramps, complete curb and gutter replacement in spot locations, and complete utility upgrades. Parking lanes within the project will be removed and the roadway template along Wisconsin River Drive will be narrowed to eliminate the on-street parking and the auxiliary lane.

The Village Board has approved and are executing our 2024 Budget. It was a hard time in making the 2024 budget. Over the years expenses have gone up, with no change in services. However, the Village has seen no growth whereby capping the Village levy limits. With no growth over the years the Village tax revenues stay stagnant.

However, the Village Tax Increment District (TID) is healthy and will be funding some major street & utility projects over the next few years.

Our Fire Department is and will be losing some long-time firefighters and wish them well, they will be missed for their excellent service. Ordinance Violations

Spring is a good time to clean up our yards and keep the Village looking like a great place to live or run a business. There are several violations of the Village ordinances which will be enforced. To name a couple:

Parking vehicles on the grass is in violation of Village ordinances. Section 17.23(2)(d) states in part: "Surfacing. All off-street parking areas shall be graded and surfaced so as to be dust-free and properly drained..."

Several violations of the building codes also exist. If you receive a letter to this effect, please make arrangements to correct the violation(s) as soon as possible to avoid being assessed a fine.

Spring Cleanup

The Village takes pride in being a very clean community. Residents expect the Village government to enforce the rules when it comes to garbage, clutter, and vehicles. Please remember:

- Garbage, appliances, clutter, etc. is not permitted to be left in public view.
- Campers, boats, etc. must be parked and stored BEHIND or ALONG SIDE houses. They are not allowed to be parked in front of the house or on the street other than for actual loading or unloading.
- DOG FECES IS NOT YARD WASTE. Raking dog feces into grass piles for the village crew to

pick up will not be tolerated. Residents doing so will be referred to the Police Department.

Garbage and Recycling

Please remember to place your weekly garbage and biweekly recyclables out for curbside pickup by **6:00 AM** each day of pickup. Recycle pickup is every other week. LOOSE GARBAGE MUST BE PUT IN BAGS BEFORE PLACING IN CONTAINER!! Please note that pizza boxes are not recyclable. If you experience less than satisfactory service, please give us a call at the Municipal Building, 715-887-3512.

After collection, containers shall be

After collection, containers shall be removed from the curb or roadside (including alleys) within 12 hours.

Leaf, Grass and Brush Pickup

As the winter ends and we start to get outside again, please remember the following:
On a weekly basis, the crew will pick up grass that is **properly** placed. Typically grass pickup is on Mondays and Tuesdays.

PLEASE NOTE: Brush will be picked up on the same week as recycling.

Please be conscientious when placing waste at the curb. Be sure no foreign objects, such as stones, metal, etc. are mixed in with the waste. One piece of metal can completely ruin a \$300 set of chipper blades. Repairing equipment takes time and money and results in delays in picking up waste so PLEASE BE CAREFUL.

- All brush and grass must be placed on the boulevard area behind the curb.
- Grass and leaves must be placed separate from brush
- Brush must be stacked neatly with the cut end facing the street.

 Roots must be removed and placed separately from the branches.

The Village generates many tons of compostable material each year. If you need compost or wood chips, please contact the Municipal Building to arrange delivery of the material. Delivery is free to Village residents.

Shelter Reservations

Reservations for the Ripple Creek Park outside shelter and Edwards-Alexander Memorial Park enclosed and outside shelters can be made by calling the Municipal Building at 715-887-3512.

Current prices for using the Enclosed Shelter are:

Resident fee with kitchen \$125.00
Non-resident fee with kitchen \$150.00

A \$25.00 refund will be issued if the building is left clean.

Residents can reserve the outside shelters free of charge while non-residents are charged \$35.00.

Street Lights

The Village makes every effort to ensure that all the street lights in town are working but we need your help. Please let us know anytime you notice a street light that is not working or not working properly. If you have internet access, you can also report street light outages directly to Alliant Energy. Go to *alliantenergy.com* and at the top of the page select *Customer Service*; then *Storm and Outage Center*. Then select *Report an Electric Outage* and fill in the required information. It is quick and easy, but if you prefer, don't hesitate to call the office 715-887-3512.

Port Edwards Water Utility Rates

The Public Service Commission requires that water rates be published semi-annually. The following rates have been in effect since September 18, 2023:

Quarterly Service Charge:

5/8" meter - \$ 16.44 3" meter - \$222.07 1" meter - \$ 41.15 4" meter - \$365.98 1½ meter - \$82.24 6" meter - \$694.98 2" meter - \$115.16

Plus Volume Charge:

First 25,000 cubic feet used each quarter - \$1.41 per 100 cubic feet Next 375,000 cubic feet used each quarter - \$1.26 per 100 cubic feet Over 400,000 cubic feet used each quarter - \$0.94 per 100 cubic feet

Quarterly Service Charge for Sprinkling Meter:

5/8" meter - \$ 5.40 1" meter - \$ 10.50 1 ½" meter - \$ 21.00 2" meter - \$ 28.00



Billing: Bills for water service are rendered quarterly and become due upon issuance following the period for which service is rendered. A late payment charge of 3 percent but not less than 50 cents will be added to bills not paid within 20 days of

issuance. This one-time 3 percent late payment charge will be applied to any unpaid balance for the current billing period's usage. This late payment charge is applicable to all customers. The utility customer may be given a written notice that the bill is overdue no sooner than 20 days after the bill is issued, and unless payment or satisfactory arrangement for payment is made within the next ten days, service may be disconnected pursuant to Chapter PSC 185, WI Admin. Code.
