To Whom it May Concern,

1. CONCEPT:

WHEREAS, a Dog Park is intended to be established upon the completion of a legal contract between the civic organization of SCENTRAILS, Inc. ("Scentrails") and the Village of Port Edwards addressing rules, finances, expectations and long-term stability;

WHEREAS, the creation of a Dog Park in Ripple Creek park and collaboration with Scentrails will be for the benefit of the Village as well as the region because it is a direct civic infrastructure improvement consistent with the Village Comprehensive Plan Goals as required by Wis. Stat. § 66.1001(2m) in that it will "support park and recreation facilities/activities and programs" and will "provide citizens with recreation opportunities throughout the park system;"

WHEREAS, in the event an agreement on cost, funding, rules and expectations as well as a long-term sustainment plan cannot be agreed on the Village may seek other opportunities to create a Dog Park with a different entity along a different timeline for execution and completion;

NOW, THEREFORE, BE IT RESOLVED that the Village Board of the Village of Port Edwards hereby approves the Creation of a dog park contingent upon the above stipulations, dated this 1st day of December, 2020. Per the Village Resolution #2020-04

2. TIMELINE:

The acceptance of this MOA will create a partnership between the Village and the Scentrail organization for the foreseeable future until further covenants between the organizations are established or until terminated.

Long-term milestones;

a. January 2021- Draft a Memorandum of understanding between the organizations

b. January- December 2021- Fundraising by Scentrails. The concept for fundraising and regular reports will be submitted to the Village administrator for passing long progress to the Village Board.

c. June 2021- Revisit the draft concept and layout of the Dog Park and refine the cost estimates. This will be presented to the February SIRC committee.

d. June 2021- Staking of the grounds by a joint team from Scentrails and the Village

e. October 2021- Soft opening of Park if some fencing is installed

December 2021- Update of Village Ordinances pertaining to animals in the parks

f. May 2022- Ground breaking event and fence installation.

g. August 2022- Installation of animal agility items, seating, other interior fence items.

Recurring Milestones;

a. Upon the completion of a fenced area the Dog Park can be utilized and thus will commence bi-weekly pet waste removal, supervised by the Scentrails organization. A pet waste composting area will be identified in the wood-line north of the park where pet waste can be deposited for composting.

b. Regular lawn care and road maintenance will be conducted by the Village Parks department. Trash removal will be conducted by the Public Works department.

c. Routine site visits by the Village police and public works will ensure proper ordinance enforcement is being maintained as well as proper care of the park.

3. FUNDING:

Scentrails will conduct fundraising to support this endeavor. The Village will provide regular support in the form of regular maintenance of the lands provided. An estimate of the costs known to date is described below;

<u>Scentrail Inc. Cost Burden:</u> Fencing for the project expected to be \$25,000 Pet agility items, waste containers, benches approx. \$5,000 Waste basket replenishments \$1,000 annually Future shelter or shade covers \$5,000 - 7,000

<u>Village of Port Edwards Cost Burden;</u> Lawn care and snow removal as part of Public Works budget, approx. \$5,000 Signage for Dog Park name, pets on leash, approx. \$2,000 Insurance coverage as part of the Village insurance plan, approx. \$5,000 Removal of playground equipment, \$2,000 Gravel install for parking along fence line, \$2,000

The Village has created a Dog Park accounting line where deposits and withdrawals for expenses will be tracked separate from the Village General Budget. Annually, separate from discussed items, the Scentrails organization will submit to the Village by July 1 of each year \$500 to be used for general dog park maintenance, separate from items listed above (which will be expensed via the Village Public Works accounts or the Scentrails organization fundraising). Any donations by residents or groups can be placed into this account for the good of the Dog Park and expended after a discussion by the Parks and Recreation committee and the Scentrails organization.

4. **RESPONSIBILITIES:**

The Village:

- a. Maintenance of the grounds via regular lawn care and trail network clearance.
- b. Snow plowing of the roads and parking areas
- c. No less than bi-weekly visits to empty the waste containers (not pet waste)

d. Providing general insurance coverage for the Dog Park

e. Providing power and security to a pending vending machine complex at the outdoor concessions.

f. Regular code enforcement by Police of Village ordinances.

g. Installation of updated signs to inform citizens of Dog Park regulations

h. Installation of the Dog Park sign once the Dog Park is named

i. Authorization for Scentrails to utilize the 4-6 acres of Ripple Creek park for a Dog Park and allow fundraising efforts on and off site to support this endeavor

Scentrails Inc.:

a. Purchase and approved installation of the fence to encompass 100% of the off-leash portion of the Dog Park

- b. Purchase and approved installation of the agility items and benches
- c. Purchase and installation of the pet waste receptacles
- d. Weekly pet waste removal to an identified composting area
- e. Replenishment of the pet waste bags at each pet waste receptacle

f. Self-policing of Dog Park rules, as well as purchase and approved installation of a designated "Dog Rules" sign.

g. Purchase and approved installation of a future shade area or shelter

h. Annual payments of \$500 to a Dog Park maintenance fund, to assist in Village administration and maintenance. These funds can only be used for DOG park issues.

- i. Fencing and/or structure repairs that necessary to maintain the park
- j. Weekly cleanup operations to address any pet waste inside the fenced area.





Q1: Are the Parks and Recreation facilities in Port Edwards adequate?





Q2: What amenities or facilities should we add in the





Q3: Are the Parks and greenspace maintained and properly represent the Village?





Q4: Are the parks well lighted, patrolled and you feel secure utilizing them?











Q8: The Village wants to include a dedicated Veterans park to honor all those who have served our Country and community. This could be at an existing park or a new park. Do you support this idea?




