- **6. Review of Edwards Alexander Park (Onsite- walk about)-** We discussed the park status and amenities from the Shelter. The Park is well maintained and has a good mixture of amenities. The one area to focus on would be the Volleyball court and basketball court upgrades.
- 7. Discussion on what Parks to focus on. The consensus from the committee is to invest our ARPA funds in overdue maintenance with small upgrades over time. To purchase large end items and neglect the existing parks regular maintenance would not be beneficial. The Administrator will craft up a list of small maintenance items (Bathrooms, Painting, Benches) to pursue over the summer and fall months across all the parks. The Challenge this year was a reduction in the Parks budget and the impact that has for regular care. The Focus parks were Ripple Creek and Edwards Alexander Park for the Village staff to focus on.

The Administrator advised on the ability to co-use the tennis court and create a pickle ball court at Ripple. Its cost prohibitive to start a Pickle ball court from scratch(\$35-\$50K). We could also include a Bags/Cornhole course at either park and that could be established by the Parks department.

8. *Community Events:* Discussed the publishing of the two calendars to highlight the Village events. Committee members appreciated the effort and look forward to it continuing.

9. Old Business:

- *a. Geese Update-* The Geese issues at Ripple Creek seem to be resolved and we will continue to monitor. The amount of Geese waste has been greatly reduced and the impacts are a walkable Ripple creek waterfront.
- **b.** County Grants- We discussed the submission of the two County Grants (Dog park and Kayak Inputs) for the parks and will discuss further once they County committee requests a update from the Village.

Village Staff,

On 8 June 2021, the Village Board approved the Village staff recommendations for the America Rescue Act funding expenditures. (Motion by Saylor/ 2nd By Mancl) 6 Ayes, 1 No (Bingham) on approval. Once we receive these funds, we will begin our purchases and projects. The accounting of these funds will be a bit more stringent than normal. While we are not required to create a separate account, we will have very detailed records on the receipt of funds and any expenditures. We will be required to provide an update to the US Treasury on our expenditure status, starting in October 31, 2021, then annually.

The following projects are approved for the Village utilizing the expected \$92,000 in 2021 America Rescue Plan federal funding. We have kept \$12,000 in reserve pending final estimates. The 2nd allocation will be discussed and distributed during 2022 Budget discussions.

\$5,000 for Village sidewalks- This will be added into the Village Public Works account for use in the next 18 months. Since this will be added to other General Funds, we will need to specifically designate what project we are applying these funds to and when they are expended.

\$25,000 for Village Park upgrades (subdivided)

- -\$3500 for new bathroom fixtures (toilets) at all Parks
- -\$1500 for all weather paint for tables and benches at all Park Shelters
- -\$2000 for concrete for repairing existing benches at all Parks
- -\$4000 for replacement of a 1989 (31+ years) Furnace at Ripple Creek park for warming house
- -\$9103 for replacement of the 1994 (27+ years) Furnace (\$3653) at the Alexander Park shelter, Includes AC and Air Filtration install (\$5450)
- @\$897, Awaiting an estimate for repair parts for Playground equipment at Ripple Creek
- @\$4000, Awaiting an estimate for resurfacing the Tennis court and Basketball court at Ripple

\$40,000 for two digital Village signs- In discussion with Rapids Signs (Local Vendor) and awaiting estimates.

\$10,000 for business signage for the Village business district- In discussion with a local business (Also a Port Edwards resident) to provide an estimate and concept sketch.

These projects have been discussed and vetted by the respective Village committees and are authorized by the federal expenditure guidance the Village has received. The costs for each project will not be more than stated. Questions, I can be contacted at 715-887-3511.
