

RE: Managing Expectations in our Village Parks

In an effort to ensure we are all on the same page, I am submitting this concept of operations in how we maintain our Village parks, cemetery and Bike trails.

Annually we place \$5K into the Capital Improvement projects. These are directed at the monthly meetings on how we will spend these funds. We set a Goal of \$15K annually.

Upcoming projects:

- -New decking for the skating pond ramp
- Fence repairs for the Edwards Alexander ball court, and moving the Ball court and a new court.
- Adding a cornhole course in Edwards Alexander
- Replacing playground items as required annually

Our Village Parks/Cemetery Maintenance Budget for 2022 is \$40,000, wages and equipment.

What we DO:

- Starting in April thru September we mow and weed weekly the Parks

- We mow and maintain the disc golf course two times a year, in the Spring and Mid-Summer

- We will paint equipment, shelters, tables every other year across all the Parks
- We will open the Skating Pond and warming house in November thru March, weather

dependent. It will be heated and the ice plowed, if necessary, after a snow storm.

- We will apply a weed inhibitor yearly to all grounds
- We will pressure wash equipment and tables benches annually
- We will maintain the ball grounds in cooperation with the Clubs
- We operate the Splash pad from Memorial Day thru the end of September from 9-7 pm.
- We mow & weed the cemetery weekly, this includes weed inhibitor.
- We water the cemetery and other Village areas as required during the spring and summer
- We mow and trim the Bike trails every 2 weeks
