 - a. **Review monthly & budget comparison reports.** The month of December/November has been busy & mostly an increase in medical type calls, NOT fires. Increased call volumes, 240/134 (2022/2021), will cause the department to expend the entire budget. We have allocated an additional 15% increase for next year. Engine 2 has been repaired and we are completing the Insurance paperwork for the \$6K cost of repair for a \$500 deductible. The rest of the vehicles are in good shape. Issue on the Brush truck and a replacement plan

needs to be discussed. This will be tied to our 2024 Budget discussions. (a \$75K item)
