- 1. Call to order: Commissioner Vruwink called the meeting to order at 4:03 PM.
- **2. Approval of previous month's minutes (4-6-17):** Motion by Commissioner Hamilton, 2nd by Commissioner Nystrom to approve the minutes. Motion carried.
- **3. Airport Manager's Report:** Airport Manager Sickler presented his April report. Sickler highlighted the progress and status of several projects and items. Tree removal is ongoing. Sickler met with MSA regarding 12/30 reconstruct. July 21 has been identified by which an agreement must be made between the Airport Commission and BECC Board of Directors in order for the runway reconstruction project to be possible in 2018. Discussions continue to take place with action anticipated at their May meeting for resolution in June prior to July 21 BOA deadline. Tree removal is underway in the neighborhood east of the airport. Motion by Commissioner Hamilton, 2nd by Chairman Vruwink.
- b. Airport Open House: Airport open house tentative dates discussed no date determined. EAA is still interested in coordinating lunch or breakfast at the event.
- c. Old Iron Americana Show: Due to a family incident the planning of the event will be delayed by as much as a couple months.
