Fire Department

Motor operating class starting on 7 Feb. Because of this 8 week class, expenses will be higher than normal during that period.

It will be more of an engagement program than a job. Second, Mid-State has its own firefighter program and Bossert will be meeting with them next week. An option could be to sign the kids up for that program. The third option would be through the state, as an apprentice for the Village.
