- Call to order: Meeting called to order by Mitchell Chairman at 4:00 p.m.
- *Roll Call:* All present from above.

- Public Safety Updates

Fire Department

a. Review monthly & budget comparison reports. Responding calls are doubled from last year. Purchased new equipment: thermal imaging camera & new radios. Public Works Supervisor Ben Martinson fixed minor issues on firetrucks. Engine 1 still awaiting back-ordered parts, engine 2 has loose wire, & engine 3 has some rust bubbling through paint. Pump operator class has ended with 10 firefighters participating. Three firefighters went through RIT (Rapid Intervention Team) training. Responders have been called twice for lift assist, if this becomes more

common, will need to discuss being compensated for time. Fire Chief presented a video he shot at the fire station & discussed what each vehicle does for the new members of the committee. Also went through a six-month rundown of the issues of the department since he became Chief.

Police Department

a. Review monthly & budget comparison reports. Working with Public Works to issue ordinance violations. 20 letters have been sent out, & 4 were ticketed for noncompliance. Drug takeback last weekend was an overwhelming success, with almost 25lbs of drugs taken in. Health Department is offering reimbursement for our officers' time. Police Chief attended Mid-State Technical College to help interview potential interns & was offered one. Squad 1 tires & brakes were replaced. Radar unit was sent in for repair. Squad 2 has minor damage from hailstorm 12th April, still functional. Inquire if insurance would cover costs (\$1,200) to replace. Enforcement is up due to warmer weather, & payroll & budget are on track.

• New Business.

a. Discussion on regulating golf carts, electric bikes & updates to ordinance. Ebikes are allowed on bike trails, will implement speed limits on our trails of 10 mph, & add stop signs. Ebike will fall under bike ordinance, registration is required. Golf carts will have limits on what roads they can drive on, registration required & not allowed to drive after 10 p.m.

• Old Business.

- a. Discuss the Bike Rodeo Concept for this Spring (Elementary school) 21 May 2022.
 - i. Manning. Bike rodeo will be from 10 a.m. to 2 p.m. at the fire station with 12 students manning four stations. Available for children K-5, must wear helmets & closed-toed shoes in order to participate. Each eligible child who registers will be entered in a drawing for a new bike. Marshfield Clinic donated 10 helmets to give to children at the rodeo.
 - ii. Tasks. Will require adult supervision. Registration fee is \$5 to cover services provided: photo & engraving on bike. Will advertise on Facebook & the village website.
- **b.** Discuss the establishment of the Public Safety Club at the High school to begin in Spring 2022.
