- ***Public Works Updates***
 - a. **Department of Public Works Report - Project Update.** Summer activities are ongoing. Alleys are complete. Some Stormwater work is ongoing. An update on the road work that will commence this summer with Chip seal, crack sealing in the Village as well as the update on Market Ave. The old section of the cemetery sprinkler system is damaged and would take over \$100K to repair. No intentions to do so. We will continue hand watering. Potential ability to do one more alley either market ave or 2nd Jefferson street will be assessed.

b. Discussion by Mrs. Wessling on the timing to resurface the Market ave alley.

Based on the length and infrastructure underlying it will be discussed in fall with the Budget. TIF money can be used. Her question was when it gets done can they add to the contract to do their portion of the roadway and driveway.

c. Bike trail discussion thru the DMI parcel. DMI agrees to support this and we will confirm the costs for use by the Legacy Grant. These costs could also include resurfacing of 1 mile of trail from Ver Bunker to Le Tender. This will be discussed at the Parks Committee.

- **New Business:** None
