The bike trail will be 10' wide. MSA is working with the DOT on safe crossing of the intersection. DOT gave the okay for a safe crossing. Martinson is finishing the design

- with MSA so the Parks Department can start collecting bids. Hoping to start in April/May/Hoping for completion by June of 2025. The plan includes putting flashing lights at the intersection for safer crossing. It will be above the driving lanes.
- *c*) Update on Christmas tree lighting. On December 10th. There was a good turnout. There was no cost to the Village. It was on social media and signage. The school also publicized. School choir/band attended/played.
- 8) Discussion on potentially installing outdoor cameras in the park shelters in 2025: Ripple Creek has had damage to locks, windows, etc. Martinson reached out to Mobile Lock & Security. \$700.00 cost per park to install 2 cameras per park. At Ripple Creek, one camera would go in the shelter and one by the restrooms. Camera takes 30 days of film then restart. Martinson will bring additional information next month.
